#### "No Excuses" Stock Selection

Cortina believes outperformance in small cap investing starts with stock selection. We search far and wide to unearth stocks that can deliver performance no matter what the market environment. Keys to selection include:

#### Intensive bottom-up analysis

We meet with more than 800 companies a year and get right down to their roots: business model, financials, management, competitive advantages, marketplace position-all the factors that affect the ability to deliver growth.



#### Valuation discipline

We scrutinize each company's operations and finances, then use a matrix of absolute and relative valuations to set a realistic target stock price. We favor cash-flow-based valuation over accounting-based metrics.

#### Consistent risk management process

We set clear price parameters and we stick to them, buying and selling accordingly. We update our valuation spreadsheet daily and use proprietary tools, such as downside alert screens, to identify potential underperformers. Our time-tested and disciplined process provides downside protection on a stock-by-stock basis.

#### Value added construction

We are "index aware," but we do not let index weightings drive portfolio decisions. We will not invest in a sector unless we find stocks with fundamentals and valuations that meet our standards.
